### Background information on the contract

## What is the scope of the contract?

The contract covers the design, supply, installation and commissioning of Heating, Ventilation and Air Conditioning (HVAC) system, the mechanical and electrical equipment for the Tokamak complex, which consists of the Tokamak, Diagnostic and Tritium buildings, plus the surrounding buildings.

## What is the duration of the contract?

The planned duration of the contract is six years.

## What is the value of the contract?

The overall value of the contract is approximately 530 million EUR.

## To whom is the contract awarded?
