DECISION OF THE GOVERNING BOARD ADOPTING THE SECOND AMENDMENT TO THE 2018 BUDGET OF THE EUROPEAN JOINT UNDERTAKING FOR ITER AND THE DEVELOPMENT OF FUSION ENERGY

THE GOVERNING BOARD OF FUSION FOR ENERGY,

HAVING REGARD to the Statutes annexed to the Council Decision (Euratom) No 198/2007 of 27 March 2007 establishing the European Joint Undertaking for ITER and the Development of Fusion Energy (hereinafter "Fusion for Energy") and conferring advantages upon it4 (hereinafter "the Statutes") and in particular Article 6(3)(e) thereof, amended on 10 February 2015 with Council Decision Euratom 2015/2245;

HAVING REGARD to Council Decision N° 791/2013 of 13 December 2013 amending decision 2007/198/EURATOM establishing the European Joint Undertaking for ITER and the Development of Fusion Energy and conferring advantages upon it⁶;

HAVING REGARD to the Financial Regulation of Fusion for Energy⁷ adopted by the Governing Board on 22 October 2007, last amended on 2 December 20158 (hereinafter "the Financial Regulation"), and in particular Title III thereof;

HAVING REGARD to the Implementing Rules of the Financial Regulation⁹ adopted by the Governing Board on 22 October 2007, last amended on 4 July 2017 10 (hereinafter "the Implementing Rules"), and in particular Title III thereof:

HAVING REGARD to the 2018 Work Programme adopted by the Governing Board on 1 December 2017¹¹, amended on 5 July 2018¹² and on 12 December 2018¹³;

HAVING REGARD to the 2018 Budget adopted by the Governing Board on 1 December 2017¹⁴, amended on 5 July 201815

HAVING REGARD to the EU 2018 General Budget published on 28 February 2018¹⁶;

HAVING REGARD to the opinions and recommendations of the Administration and Management Committee on the proposal for the second amendment to the 2018 Budget at their meeting of 21-22 November 2018¹⁷. WHEREAS:

(1)The Director should, in accordance with Article 8(4)(e) of the Statutes, draw up the annual budget;

- (3) The Governing Board should adopt the annual budget which becomes definitive after final adoption of the general budget setting the amount of the Community contribution and the Establishment plan;

HAS ADOPTED THIS DECISION:

Article 1

The second amendment to the 2018 Budget of Fusion for Energy annexed to this Decision is hereby adopted.

Article 2

The Decision about the additional EUR 790 000.00 in administrative is subject to the adoption by the Budgetary Authority of the relevant amending budget/transfer of the European Union Budget.
